To make examination system more reliable, transparent, and accountable and to promote digitalization in the system, SDPC has taken a step forward through online exam form filling with VMS portal and pay their fees through digital gateway.

Instruction for HODs

1. HODs will be able to **Reject (Disapprove)** the exam forms of **Regular** students after the completion of exam form filling period.
 2. Exam forms of **Regular** students on institute website/VMS will be shown as approved by **Default**.
 3. No exam form will be approved/disapproved (reject) after the scheduled date of HODs is over. Sufficient time is given to all HODs so take proper care during approval/disapproval.
